Cancellations: All cancellations must be notified in writing. A cancellation fee will apply as follows:

Written notification received by Musica Viva	Cancellation Fee
Within fourteen (14) days of the scheduled concert/s or workshop/s	Per concert cancelled Total Minimum Student Fee
Between fifteen (15) and twenty-eight (28) days of the scheduled concert/s or workshop/s	50% of the applicable Total Minimum Student Fee
More than twenty-eight (28) days of the scheduled concert/s or workshop/s	No charge

Invoicing: Musica Viva will send your school a Tax Invoice for all charges on receipt of your booking.
